- Two letters of recommendation in sealed envelopes
- Official TOEFL or IELTS score. We require a minimum TOEFL iBT score of 85 or paper-based score of 563. Our minimum IELTS score is 6.5.
- A written personal statement
- Current résumé

LL.M. applications are reviewed on a rolling basis, which means the committee reviews each applicant's file once it receives all application materials.
